P.Abdelmaseh (AASP) stated that certain appraisers have been solicited to join the Direct Repair Pay Program and were told that SB 453 has already been passed. It is being presented to the Insurance Industry as an alternative to Labor Rate Bill and if passed, would allow closure of many shops.

C. Garcia opined that Direct Repair Pay is here and isn't going anywhere. We should create an even playing field.
