Need to Know

Who: Excavators, contractors and residents that are planning outdoor projects.

What: A public awareness campaign to promote safe digging practices and avoid utility disruptions, fines, and injuries.

When: The entire month of April.

Why: Excavations are the leading cause of damage to underground utility infrastructure and can cause serious personal injury, property damage, and disruption in utility services. Whether an outdoor project is installing a mailbox or fence, planting trees or shrubs, or something more involved, anyone intending to dig or excavate should call 811 before starting.

Suggested Text for Posts

- 1. April is National #DigSafeAwarenessMonth in Massachusetts! Before you dig, call Dig Safe at 811 before putting a shovel in the ground to ensure that no underground lines are impacted. Calling is safe and free, and it's the law.
- 2. April is #SafeDiggingMonth in MA, ME, NH, RI, and VT! Be sure to call 811 before putting a shovel in the ground. #DigSafe
- 3. Outdoor graduations, weddings, holiday cookouts are on the horizon. Even one stake tent could cause damage to underground utility lines. Contact #DigSafe at http://digsafe.com or #Call811 before installing a tent about a week before your event.

- 4. Do you know what's below? Calling Dig Safe at 811 before you dig avoids costly and potentially dangerous damage to underground utility infrastructure. Visit https://www.mass.gov/dig-safe or www.digsafe.com for more information. #DigSafeAwarenessMonth"
- 5. Installing a mailbox or fence? Building a deck? Planting trees and shrubs? Every digging project, no matter how large or small, warrants a call to 811. Avoid damage to underground utility infrastructure by calling 811 before you dig. #DigSafeAwarenessMonth
- 6. In 2023, there were 852 excavation-related damages to utility infrastructure in Massachusetts. Before starting any digging project, even projects on private property, you need to call Dig Safe at 811.
