The Board Members of the Worcester Retirement System (hereinafter “Board”) are seeking proposals from managers of global diversified open- or closed-end private infrastructure funds with a focus on the large cap market segment, as defined by a fund size of greater than \$15 billion and an average asset size of greater than \$1 billion.

The Board intends to commit approximately \$20 million. Only proposals from infrastructure managers of open- or closed-end large cap private market infrastructure funds will be considered. Responding firms must have experience managing global diversified strategies. Public equity, sector-specific strategies, or Fund of Funds will not be considered. The objective of this Request for Proposal shall be to identify the manager(s) whose expertise will best meet the Board’s goals and needs. The Board reserves the right to reject any and all proposals at its discretion.

The selected manager(s) must have familiarity with, and agree to comply with Massachusetts General Laws, Chapter 32 and Chapter 176, the regulations of the Massachusetts Division of Public Employee Retirement Administration Commission, 840 CMR, and the PERAC Placement Agent Policy.
