Staffing Ratios

Recovery Specialists: 1:16 Recovery Specialist to patient ratio for Day/Evening Shifts, 1:20 for Night Shift. These positions are <u>not</u> pro-rated by bed number. **Care Coordinators/Case Managers:** 1:16 Care Coordinator/Case Manager to patient ratio; 8 hours per day; 5 days a week

Counselors: 1:8 Counselor to patient ratio; 12 hours a day; 7 days a week

Counseling Coverage

The Counselor ratio of 1:8 is over a minimum 12-hour span per-day. This equals 1.5 hours of counseling coverage per-bed, per-day. Programs have the option to allocate counseling coverage beyond the 12-hour minimum span per-day, as long as the daily total hours of counseling coverage are met.

Nursing Coverage

Nurse: minimum of 40 hours coverage per week, 7 days a week; nursing hours of coverage increases according to licensed beds

- These staffing ratios are *minimums* that should be adjusted upward to address patient acuity and programmatic need.
- Shifts are considered as day, evening, and night
- All programs must have at least one individual on duty that is CPR certified
- All co-ed programs must have male and female staff on all shifts
- Nursing may be filled by a Qualified Health Care Professional: A Practitioner, Registered Nurse, or Licensed Practical Nurse trained do physical assessments, duly licensed, certified or registered as such in the Commonwealth of Massachusetts, and practicing within the scope of applicable Massachusetts and federal regulations
