#### **Benefit Verification Process**

Up to now, retirees and beneficiaries who receive a retirement allowance were required to participate in the Benefit Verification process. This event has been conducted every two years. Recent PERAC Regulation CMR 840 15.01 was amended. *Therefore, retirees and beneficiaries no longer need to complete the Benefit Verification form.* 

The amended regulation requires that MSRB comply by performing a data match of the demographic information and status of current retirees and beneficiaries receiving benefits no less than semiannually by a third-party entity contracted through an approved selection or procurement process. MSRB has a current process in place to comply with the regulation. This relieves retirees and beneficiaries of the administrative burden of completing the form. You can expect to receive a letter in the mail from MSRB that explains the change.

## Governor Proposed a 3% COLA for FY'25

Governor Healey included a proposed 3% COLA (Cost-of-Living Adjustment) increase for retired state employees within her <u>FY'25 budget proposal</u>. Per the

# *Did You Know?* Working in Retirement

If you are interested in working in retirement, it's important to be aware of the limits.

Those receiving a superannuation retirement benefit and working in the public sector must stop working if they work 1,200 hours in a calendar year and/or earn the difference between the current salary of the position they retired from and their pension. After being retired one full calendar year, they can earn an additional \$15,000.

As a retiree, you must cease employment whenever either one of the above two conditions is met. You must waive your retirement allowance if you are at your allowable limit and wish to continue working. budget proposal, this would apply to the first \$13,000 base of the pension benefit.

The Governor is also <u>proposing the</u> <u>creation of a special commission</u> that would study the COLA and explore methods of funding timely periodic costof-living adjustments for retired state employees and teachers.

At the time of this publication, the House and Senate had not yet submitted their FY'25 Budget drafts.

If enacted by the Legislature, the COLA will go into effect on July 1, 2024, for those who retired before July 1, 2023. As the COLA is a legislative item, please direct any questions about the amount, base, or drafting of COLA to your local <u>State Legislator</u> or the <u>Governor's</u> <u>Constituency Services Office</u>.
